Priority Deadline: May 15, 2017

Application materials received at Wesleyan after May 15, 2017 are subject to a \$1,000 penalty and a \$2,000 penalty if after July 15, 2017. The loss of scholarship will be replaced with available loan funding. Through your Electronic Portfolio, under My Financials you may access SIMON, our web-based service, for information on the status of your financial aid application and forms needed to complete your application. Guest access to your Electronic Portfolio may also be granted to those persons who may help you complete the application process.

- ❖ If we receive all documents noted below by the May 15th priority deadline, we will notify you by email in June to see your award in SIMON.
- ❖ Student Accounts will email you when your E-Bill is ready in July through your E-portfolio.
- ❖ Wesleyan reserves the right not to award any institutional funds if an application is completed after August 1, 2017.
