HOUSING & DINING

On-campus housing is available on a limited basis for the Summer Session; students are not required to live on-campus. Students residing in campus housing will pay a Residency Fee of \$744 for room only; students are required to provide their own meals.

Dates:

- Session I Housing will open on Tuesday, May 27, 2014. Session II Housing will open Sunday, June 29, 2014
- Students must vacate campus housing and return all keys to the Office of Residential Life by 1:00 pm Friday, June 27, 2014 for Session I, and by 1:00pm Thursday, July 31, 2014 for Session II
- Limited transition housing is available for Wesleyan students only from the Office of Residential Life; information is available on their website.

To qualify for on-campus housing, students must:

- Certify that they have been graduated from high school
- Certify that they are at least 18 years old
- Provide proof of compliance with the State of Connecticut immunization requirements
